- (A) Case #Z14-005:** Hold a public hearing and consider a request for a variance to Section 5.3-2(a)(1) to allow a proposed fence to be constructed at a height of ten (10) feet rather than the maximum allowed height of eight (8) feet at 3891 N IH 35 in the "M-1" Light Industrial District.

- (B) Case #Z14-006:** Hold a public hearing and consider a request for a variance to The Enclave at Westpointe Planned Development District Development Standards to allow a 2.5-foot encroachment into the five-foot side setback for a house at 362 Wauford Way.

- (C) Case #Z14-010:** Hold a public hearing and consider a request for variances to:
1) Section 3.3-2(b)(2)(ii) to allow elevated decks to encroach 12 feet into the 25-foot front setback; and
2) Sections 3.3-2(b)(2)(iii) and (v) to allow elevated walkways to encroach up to 15 feet into the 20-foot rear setback and five (5) feet into the five (5)-foot side setbacks in the "R-2" Single-Family and Two-Family District at 240, 250 and 262 Rio Drive.

- (D) Case #Z14-011:** Hold a public hearing and consider a request for variances to Sections 3.3-9(b)(iv) and 5.1-3(b) to allow a proposed commercial building to encroach up to six (6) feet into the 20-foot rear yard setback and to allow 32 off-street parking spaces rather than the minimum of 39 required off-street parking spaces at 1200 IH 35 North in the "C-3" Commercial District.
