

DEFERRED DISPOSITION REQUEST

I hereby enter my appearance to the offense of _____,
Citation or Docket Number _____. I understand that I have the right to a trial, and hereby waive my right
to trial, plea NO CONTEST, and request the Court grant me an order deferring the disposition of my case.

I understand that with this request I **must**:

1. Submit a copy of my photo ID;
2. Submit a copy of my valid insurance listing me as a driver on the policy at the time of the violation IF the violation is for failure to maintain financial responsibility;

I understand that the deferred period will end in **90 days or 180 days (depending on citation)** from the date that this request is **processed by the Court** and during that time and before the end of that period, I will:

1. Pay the court costs within 30 days, and the special expense fee by the end of the deferral period,
2. Not receive any new offenses,
3. Provide and maintain current contact information with the court for the duration of the deferral period,
4. Abide by these additional conditions (as applicable)

a. Moving Violations - 90 day deferral, If you are less than 25 years old, you must complete a Driving Safety Course approved by the Texas Department of Licensing and Regulation (TDLR). The certificate MUST list New Braunfels Municipal Court and will say "COURT COPY." Courses can be found here:

Please note: If, you hold a provisional driver's license, you must also present proof that a driving test re-examination by the Texas Department of Public Safety was completed.

b. Driving While License Invalid, No DL, & Expired DL- 180 day deferral, you **must** submit proof that you obtained a current, valid driver's license or occupational driver's license by the end of your deferral period;

c. Failure Maintain Financial Responsibility - 180 day deferral, you **must** maintain insurance during the deferral period. The Court will verify coverage. If your insurance changes, you must provide the Court with a new copy of your valid insurance listing the vehicle driving at the time of the violation as covered.

Payment may be made AFTER you have been notified that your request for deferred has been approved.
