

**Guadalupe-Blanco River Authority**

The Guadalupe-Blanco River Authority ("GBRA") has, in addition to the requirements of the City of New Braunfels, an independent review process for developer utilities which sets forth standards and design guidelines for developer utilities ("Standards"). ## Exhibit A

THESE REQUIREMENTS ARE NOT A COMPLETE SUMMARY OF THE TASKS THAT APPLICANT MUST COMPLETE TO OBTAIN SERVICE FROM GBRA.

1. Execute a wastewater service agreement with GBRA prior to commencement of plan review by GBRA staff.
2. Provide complete design submittals for GBRA review and approval prior to bidding. Include master plan, plats, easements, design calculations, specifications, and complete project drawing sets including roads, grading, storm sewer, sanitary sewer, water, dry utilities, etc. Reference GBRA standards and design guidelines at the following website for additional requirements: <https://www.gbra.org/public/waterwastewaterservices.aspx>
3. Provide GBRA with dedicated easements for the property where the wastewater infrastructure will be located. Such easements shall not overlap or be located within residential lots. If located outside of public right-of-way, such easements shall have a minimum width equal to pipe outside diameter, rounded up to the nearest foot, plus ten (10) feet minimum on each side. For easements with multiple pipes, provide ten (10) feet minimum horizontal clearance between pipes. Provide additional width for easements that are not located adjacent to public right-of-way.
